

Therefore, the facilities provided to the Directors/Non-Official Directors are fixed directly by the Ministry of Social Justice & Empowerment (MOSJ&E) at the time of appointment.
	c) Criteria for appointment of Chairman/ Members	Out of 3 posts of Non-Official Directors, one post of Director relates to expert in Sanitation Technology and two posts of Directors shall be from Safai Karamchari Community, of which preferably one should be a woman engaged in manual scavenging.
