Subject: Evaluation Studies of NSKFDC Schemes in the States of Bihar, Orissa and Punjab.

Sir,

NSKFDC was incorporated on 24/01/1997, a Company not for profit under section 25 of the Companies Act, 1956. The main objective of the Corporation is to promote socio-economic upliftment of Scavengers/Safai Karamcharis and their dependents.

In this connection, it is informed that NSKFDC has been implementing its schemes and programmes through the State Channelising Agencies (SCAs) nominated by the concerned State/UTs Government in their respective State/UTs. The project proposals are being prepared by the SCAs for providing loan under viable income generating activities and sent to NSKFDC for their sanction. On the basis of proposals sanctioned by NSKFDC, the funds maximum upto 90% of the project cost is being provided to the beneficiaries through SCAs at concessional rate of interest.

As per MoU for the financial year 2010-11, NSKFDC is required to conduct Evaluation Study in three States/SCAs for assessing the impact of schemes on the target group of NSKFDC which must be completed **by 31/03/2011**.

In this regard, NSKFDC has selected three states viz. Bihar, Orissa and Punjab for conducting the Evaluation Study considering the population of the target group and the States/UTs not covered earlier for conducting of Evaluation Studies.
